In January alone, 41 cases of enforced disappearances have been reported and 25 individuals recovered after severe physical and mental torture. Four Sarmachars have been killed by Pakistani Forces.



An overview of Human Rights Situation on Month of January 2023

The month of December 2022 and the beginning of 2023 have seen a noticeable increase in the number of extrajudicial killings and enforced disappearances in Balochistan. In January alone, 18 students and a journalist including 41 cases of enforced disappearances have been reported, with 14 individuals recovered after severe physical and mental torture.

This trend is a clear violation of international law and the UN conventions against extrajudicial killings and enforced disappearances. The right to life and freedom from torture are enshrined in numerous international agreements, including the Universal Declaration of Human Rights, the International Covenant on Civil and Political Rights, and the Convention Against Torture and Other Cruel, Inhuman or degrading Treatment or Punishment.

The recovery of these 10 individuals is a pleasant news. But at the same time kidnapping innocent people and subjecting them to inhuman torture without judicial process highlights the alarming trend of human rights violations towards Baloch people. Torture is universally condemned and is prohibited under international law, yet still these practices continue to be used as a means of repression and control in Balochistan.

The year 2022 saw a total of 11 people recovered from enforced disappearances. These incidents underscores the importance of ensuring the protection of human rights activists, who are often targeted for their activism and advocacy for political, economic and social rights of Baloch people.

The current trend of extrajudicial killings and enforced disappearances, along with the inhuman and cruel use of torture, is a slap on international community and guardian of human rights all over the world. The international community must take action to hold Pakistan accountable and to ensure the protection of human rights for all. The UN and other international organizations must work to monitor and investigate these cases, and to provide support and assistance to the victims of torture, and their families.

At the end, we find it relevant to mention that it was encouraging to observed on 42 session of UNP (Universal Periodic Review) in UN, countries like India, Israel, Netherlands, Italy, and Paraguay have urged Pakistan to end enforced disappearances, and ratify the convention on Enforced disappearances and hold accountable those who are involved in its violation.

The representatives of these countries also addressed their concerns regarding the human rights of religious and gender minorities which are being violated in Pakistan.
