## An overview of Human Rights Situation in Month of February 2023

In the month of February 2023, Military operations, arrests, and forced disappearances persisted, and there was a surge in cases of forced disappearances, including Baloch women. The report documented 39 cases of forced disappearances, with two women, Rashida Zehri and Mahal Baloch, among the victims. Mahal Baloch, who was first subjected to forced disappearance, then was portrayed as a militant and charged with false accusations. One person identified as Dad Bakhsh Miskan was summoned to a military camp in the Geshkaur area of Awaran district and subjected to brutal torture in such a way that after his release, he succumbed to his injuries and died.

Our report also reveals that 13 persons were released after being subjected to severe physical and mental torture following illegal and unconstitutional enforced disappearances. This highlights the grave human rights violations against the Baloch people, who have been subjected to inhumane treatment without trial.

The Pakistani army is committing war crimes beyond the law, constitution, and human values in Balochistan. Baloch political parties and organizations have been pointing out the humanitarian crisis in Balochistan, but the voices of the people have gone unheard. The human rights violations committed against the Baloch people are a serious concern for the international community and human rights institutions around the world.

PAANK urges international organizations and human rights working organizations to hold Pakistan accountable for the crimes committed in Balochistan and take practical action against this initiative. Failure to address these human rights violations will exacerbate the humanitarian situation in Balochistan, and PAANK believes that the international community must take action to prevent the human rights violations from happening.
